CHARITY STATUS APPLICATION TIMELINE

- 1. The Charity Commissioners' Model Constitution was adopted on the 22nd of August 2020 by the BCLTS Committee (2019-2020) at a Committee Meeting.
- 2. BCLTS successfully registered as a charity on the 1st of September 2020. All the information can be found on the Charity Commission website. The registration number is 1191084.
- 3. Seven physical signatures were collected and submitted to Charity Commission to complete the final application procedure.
- 4. Outgoing committee members are to be removed as trustees. (To be completed)
- 5. Adding present committee members as current trustees will involve filling forms and vetting. (To be completed)
- 6. Charity registered address to be changed. (To be completed)
- 7. Amendment of BCLTS charity constitution includes items such as membership, election method for officers and their term of service to be fully discussed and agreed at 2021 AGM before submission to the Charity Commission for approval.

ANSWERS TO COMMON QUESTIONS

Q: What do we need to do differently now that BCLTS is a registered charity?

A: It is business as usual for members. The Committee need to submit a formal report and annual financial accounts in August 2021.

Q: Did you still need to submit outgoing members' physical signatures after they had stepped down?

A: Yes. The CC accepted our application provisionally on the condition that these physical signatures would be provided in due course.

Q: Should outgoing committee members be removed from the website as trustees immediately after their retirement?

A: There is no urgency, but at the same time, newly elected members should be added as trustees.

Q: Can we amend the constitution now?

A: Compared to submitting frequent small changes to the CC, it is more beneficial to fully discuss all the issues under consideration for amendment and reach internal agreement before submission.

Research Publications

Based on information collected via BCLTS mailing list in October 2020, our members have published 16 peer-viewed journal articles, 2 books and 4 book chapters since 2019. The research themes include the study of interlanguage in Chinese language acquisition, Chinese character learning, new technology in language teaching, language policy, language assessment, medium of instruction, phenomenology of Chinese language, and culture studies.
